## **GENERAL SUMMARY**

Plans, directs and manages the activities and operations of the Property Management Department including Facilities Management, Fleet Services, General Services and Real Property. Coordinates assigned activities with other departments and outside agencies. Provides complex strategic and administrative support to an Assistant City Manager.

#### **ESSENTIAL DUTIES & RESPONSIBILITIES**

The intent of this job description is to provide a representative summary of the major duties and responsibilities performed by incumbents of this job. Incumbents may be requested to perform job-related tasks other than those specifically presented in this description.

- 1. Directs the activities of the Property Management Department, which includes planning, coordinating, administering, and evaluating programs, projects, processes, procedures, systems, standards, and/or service offerings; ensures compliance with federal, state, and local laws, regulations, codes, and/or standards.
- 2. Leads efforts in evaluating proactive strategic initiatives and opportunities that will advance the staff's ability to coordinate with impacted internal and external stakeholders.
- 3. Supervises staff efforts in collaborating with departments and external agencies to identify optimal property decisions to ensure maximum benefit and use from shared facilities.
- 4. Oversees staff who are responsible for planning, development utilization and maintenance of a majority of city facilities including but not limited to architectural and construction management services citywide. Maintenance of the City's fleet, general administrative services including Utility administration and Fuel Services, and Real Estate Services including but not limited to Real Property, Tax Foreclosed Property, Lease Administration, Mineral Management and Lake Worth Lease.
- 5. Supervises staff, which includes prioritizing and assigning work; conducting performance evaluations; ensuring staff is trained; ensuring employees follow policies and procedures; maintaining a healthy and safe working environment; and, making hiring, termination, and disciplinary decisions or recommendations.
- 6. Establishes appropriate service and staffing levels; monitors and evaluates the efficiency and effectiveness of service delivery methods and procedures; and allocates resources accordingly.

- 7. Assesses and monitors work load, administrative and support systems and internal reporting relationships; identifies opportunities for improvement; and directs and implements changes.
- 8. Leads the development and administration of the department budget; approves the forecast of funds needed for staffing, equipment, materials and supplies; approves expenditures; and implements budgetary adjustments as appropriate and necessary.
- 9. Explains, justifies and defends planning and development programs, policies and activities; negotiates and resolves sensitive and controversial issues; and participates in the writing of new rules and regulations and/or proposals for new programs or projects.
- 10. Represents the Property Management Department to other departments, elected officials, developers, outside agencies, and general public; participates on a variety of boards, commissions and committees; and provides staff support and technical guidance to assigned boards and commissions.
- 11. Performs other related duties as required.
- 12. Adheres to assigned work schedule as outlined in the Department and City attendance policies and procedures; ensures all behaviors comply with the City's Personnel Rules and Regulations.
- 13. Pursuant to the City of Fort Worth's Code of Ordinances and Personnel Rules and Regulations, employees in this position cannot file an appeal of disciplinary actions taken against them.
