Submitter Comments: Similar to Citizens Compact Plan A. Bonnie Brae moved from District 4 to District 2 to join rest of Riverside Alliance, requiring adjustments to Districts 1, 3 & 7 to re-distribute population; Districts 1 & 3 are intentionally underpopulated for future growth. Similar to Compact Plan A. Bonnie Brae neighborhood moved from District 4 to District 2 to join other neighborhoods in Riverside Alliance.

Readjusted Districts 1, 2, 3, 4 & 7 to distribute population - overall deviation = 7.3%.

Underpopulated Districts 1 & 3 for future growth.

Like Plan A, Plan B has 8 majority-minority districts based on total population, 5 majority-minority districts based on voting age population; 5 minority opportunity districts based on voting age population and 60% threshold, 4 opportunity districts based on voting age and 65% threshold.
