2019 Agreement for Disposal of Liquid Waste

This agreement is entered into on the _____ day of _____ ,
20 ____ by and between the City of Fort Worth and _____
_____ hereinafter referred to as "Hauler".

1.

Hauler agrees to dispose of only septage and/or chemical toilet waste only at the designated location at The City of Fort Worth Liquid Waste Transfer Station located at 3288 Yuma Drive, Fort Worth, TX 76106, hereinafter referred to as Yuma Disposal Site. Disposal of waste types other than septage or chemical toilet waste is prohibited unless the hauler has received prior written authorization from the City. The locations for disposal shall be directed by authorized staff at Yuma Disposal Site. Unless exempted, Hauler further agrees that, prior to any disposal, to have an approved trip ticket as issued by the City of Fort Worth Water Department Pretreatment Services Division. The City of Fort Worth trip ticket books have been designated as the only trip ticket books to be accepted at Yuma Disposal Site by the Director, and can be purchased at the PSD offices at 920 Fournier Street for a fee established by the City Council

2.

Hauler agrees, based upon the current rates for treatment and disposal, monitoring, sample analysis and enforcement, to pay the City of Fort Worth for the volume of waste disposed. Volume of waste shall be that as determined by vehicle tank size as contained in the records of the City of Fort Worth Industrial Waste Section. Rates are subject to revision as may be approved by the City Council of the City of Fort Worth. Invoices shall be rendered to Hauler on a monthly basis and said invoices shall be due and payable to the City of Fort Worth thirty (30) days from date of invoice. Payment shall be made at Fort Worth Water Department, 908 Monroe Street, Fort Worth, Texas 76102. Failure to make payments in accordance with this agreement shall be grounds for an increased deposit and/or suspended/terminated disposal privileges. The City of Fort Worth reserves the right to deny Hauler the right to dispose if payment is not made within thirty (30) days or the Hauler is delinquent in the payment of disposal fees.

Hauler agrees to make a deposit, in advance of the first disposal, in an amount of money which will, in the judgment of the Director of the City of Fort Worth Water Department, be sufficient to ensure the City of prompt payment of invoices. At a minimum, the deposit shall be equal to an estimated one (1) month charge for disposal at Yuma Disposal Site.

4.

Drivers are expected to enter the Yuma Disposal Site yard and check in immediately at the office on the east side of the facility. In the event of a spill of septage and/or chemical toilet waste within the Yuma Disposal Site caused by Hauler, Hauler agrees to clean up said spill. If Hauler fails to act, the City of Fort Worth may perform the clean up and invoice Hauler for all costs incurred as a result. Hauler agrees to pay the City of Fort Worth within thirty (30) days of the date of the invoice for such costs.

5.

Disposal by Hauler shall be made at the Yuma Disposal Site Monday through Friday of each week between the hours of 8:00 o'clock a.m. and 4:00 o'clock p.m. except for City of Fort Worth holidays. Upon prior notice, exceptions to this schedule may be made by the Director of the City of Fort Worth Water Department or his duly authorized representative. Hours of Operation are subject to change throughout the year – haulers will be notified via E-mail and telephone prior to any changes.

Hauler designates _____ as his duly authorized representative. Such representative may be changed only in writing signed by Hauler. Hauler's address for invoice is _____
